Supply and Delivery of One (1) Emergency Tender and One (1) Water Tender for the Trinidad and Tobago Fire Service, Ministry of National Security

Tenders are invited for the Supply and Delivery of the following vehicles to the Trinidad and Tobago Fire Service, Ministry of National Security:

Item 1: One (1) Emergency Tender (Fully Equipped)

Item 2: One (1) Water Tender (Fully Equipped)

Tenderers are required to register in the Procurement Depository on the Office of Procurement Regulation (OPR) website at www.oprtt.org, on or before the closing date of this Tender, for your bid to be considered.

The Ministry of National Security will host a **Pre-Submission Meeting on Friday August 25**, **2023, at 10:00 a.m. (GMT-4) via Microsoft Teams Meeting**. It is recommended that persons involved in the preparation of the Tender submissions be present at this meeting.

Tenderers are required to provide an original and three (3) copies and an electronic copy (flash drive) of the tender. These documents should then be placed in sealed envelopes addressed to the Manager, Public Procurement, Ministry of National Security, Temple Court II, 52-60 Abercromby Street, Port of Spain, and clearly marked on the outside:

"Tender for the Supply and Delivery of One (1) Water Tender and One (1) Emergency Tender for the Trinidad and Tobago Fire Service, Ministry of National Security"

Envelopes must be deposited in the Tenders Box located on the First Floor, Temple Court II, 52-60 Abercromby Street, Port of Spain, **no later than 2:00 pm on Wednesday September 13, 2023.**

Tenders will be opened shortly thereafter at the Ministry's Office. Tenderers or their authorized representative may be present at the opening. Tenderers are also asked to note that the dimensions of the **SLOT** of the Tenders Box are **37.5 cm x 5.5 cm** and as such, tenders should be packaged accordingly.

Late tenders **<u>will not</u>** be considered in any circumstances.

The Ministry does not bind itself to accept the lowest or any other tender.

The Ministry reserves the right to cancel the bidding process in its entirety or even partially, without defraying any cost incurred by any firm in submitting their tender.
