



INSTRUCTIONS FOR APPLYING FOR A
CERTIFICATE OF IMMIGRATION STATUS (CIS)

MINISTRY OF NATIONAL SECURITY IMMIGRATION DIVISION

WHO SHOULD APPLY FOR A CERTIFICATE OF IMMIGRATION STATUS (CIS)?

- 1. A Certificate of Immigration Status (CIS) is issued as documentary evidence of a person's status as a Resident or a Citizen of the Republic of Trinidad and Tobago.
- 2. A Certificate of Immigration Status bears the Applicant's bio-data information and photograph and details the basis on which Trinidad and Tobago Resident or Citizenship Status was acquired.
- 3. An application for a Certificate of Immigration Status (CIS) is made on a CIS Application Form.
- 4. A Certificate of Immigration Status (CIS) is issued to the Applicant, if the application is approved.

PLEASE NOTE THAT THE INTERVIEWING OFFICER RESERVES THE RIGHT TO REQUEST ADDITIONAL DOCUMENTS

HOW TO APPLY FOR A CERTIFICATE OF IMMIGRATION STATUS (CIS)

All requested supporting documents must be submitted with your application.
Failure to submit the required documents, may result in rejection of your application.

Required Documents (Original and Copy):

- ☐ Completed CIS Application Form.
- ☐ Two (2) identical Passport Sized photographs:
 - Not older than six (6) months.
 - Must be taken on a white background,
 - Must be well-lit, unmounted and unretouched.
 - Head must be bare, unless headwear is for religious or medical purposes.
 - No spectacles or sun glasses are allowed.
- ☐ Birth Certificate, with supporting Statutory Declaration (where applicable).
- ☐ Marriage Certificate(s), with supporting Statutory Declaration (where applicable).
- ☐ Divorce Decree(s) (where applicable).
- ☐ Death Certificate(s) (where applicable).
- ☐ Deed Poll(s) (where applicable).
- ☐ Current passport and all previous passports and/or travel documents held by Applicant.
- ☐ Applicant's NIS Contributions (where applicable)
- ☐ Three (3) letters of recommendation (*applicable to adults*).

Submit three (3) letters of recommendation from Trinidad and Tobago nationals who know you and can attest to your continuous residence in Trinidad and Tobago. (Copy of Valid Trinidad and Tobago National ID or Trinidad and Tobago Passport is required from each recommender.)

- ☐ Birth Certificates of Applicant's children, with supporting Statutory Declaration (where applicable).
- ☐ Parents' citizenship information.

For persons residing in Trinidad and Tobago before 1976 and persons who became resident due to being the minor child of a Citizen or Resident, the following must also be submitted:

- ☐ Parents' Birth Certificates, with supporting Statutory Declaration (where applicable).
- ☐ Parents' Marriage Certificate (where applicable).
- ☐ Parents' Passports and or Travel Documents (Valid and Expired).
- ☐ Parents' Certificates of Registration, Naturalisation or Certificates of Citizenship or Certificates of Immigration Status.
