REGULATIONS

MADE BY THE MINISTER UNDER SECTION 44 OF THE IMMIGRATION ACT  
AND SUBJECT TO NEGATIVE RESOLUTION OF PARLIAMENT

THE IMMIGRATION (AMENDMENT) (NO. 2) REGULATIONS, 2025

1. These Regulations may be cited as the Immigration (Amendment) Citation (No. 2) Regulations, 2025.
2. These Regulations shall have effect from 1st January, 2026. Commencement
3. In these Regulations, “the Regulations” means the Immigration Interpretation Chap. 18:01 Regulations.
4. The Regulations are amended by revoking the Third Schedule and substituting the following Schedule: Third Schedule revoked and substituted

“THIRD SCHEDULE

FEES FOR VISITING AND CLEARING OF SHIP BY IMMIGRATION OFFICER

*(Regulation 51)*

I.	For visiting or clearing a ship between 4.00pm to 8.00am on ordinary days of the week and on Saturdays, Sundays and public holidays.	\$200 for the first 3 hours and \$100 per hour after, or part thereof;
II.	For any Immigration Service to vessels other than visiting or clearing.	Times and fees as at I above.”.
